who initiated the termination her signature was on there, she had to be the second or the original starter of the termination. She said it was the board, I spoke to several members of the board and they said no it was through her, I spoke with the old city Chief and he said he didn't do it. I just want to get a little clarification on why I was?"

Mayor Kaylor, "First off thank you for putting the badge on in cases like this the only thing I can do is refer to our city attorney. It's beyond my control I do thank you for what you did do why you was here."

Mr. Fairbanks, "Okay."

Mayor Kaylor, "The rest of the board is here, but that's my opinion. Any case like this I refer to the city attorney."

Mr. Fairbanks, "Okay, so no one can tell me who initiated the termination?"

Mayor Kaylor, "My suggestion is see the city attorney."

Mr. Fairbanks, "Okay."

Mayor Kaylor, "You can ask the rest of them."

Mr. Fairbanks, "So do I need to just get with you?"

Attorney Farmer, "Yes, you can make an appointment at my office?"

Mr. Fairbanks, "Thank you."

#### **Beautification Committee**

Kay Thurman, "First of all let me say I appreciate everyone sitting up there, the years David has worked on the Park board and senior type activities. I have really come to appreciate Bill he's dogged the job you'll have assigned him to do, but he's fair I know Jimbo has been involved one way or another in the city business either the fire department or something for years and years and years. We worked hard in the flood time I know your contacts and positive interaction with people in the county that has benefited this city in reducing money and so forth. I just want to say I appreciate that Anthony isn't here but the fact that he had a great concern in lighting I appreciate that given that all my property I can walk without breaking my neck. There are three critical problems in this town, and I don't know how many times I have come here, and the attorney has been here several times when I have presented the way we look. There are three things that are critical for this town and one is what we're setting on a leg and we got to keep that stream clean and thank God for the county manager to get those Gideon baskets it's something you can't forget most of the community is in a flood zone. Many situations and locations are in a flood way I want to say something about it's not about the beautification committee, because I happened to attend a FEMA meeting during that time. FEMA representative at the time made it clear you could lose the ability to buy flood insurance. In Graysville there shouldn't be variances relative to the flood and if we were to lose flood insurance. We're talking about not being able to mortgage your home, to maybe help your child through college, and buying and selling property if you don't have cold cash no bank is going to give you the money if you're sitting in a flood zone you don't have flood insurance. That's a critical thing the other thing is our septic system and what that does in some ways positive because where at distance from one another I sort of like that. In a another since it benefits were a bedroom community it limits the development and that can occur in our area a significant amount of land to be dedicated to the fill lines you know from apartments and so on and so forth. The

third thing is the most immediate most critical influencing in helping us with floods, and eventually a septic system and 1,000 other things and that is our appearance. That's been a major concern of mine and for those of us that live here cleanliness is the concern for us because it impacts value of our property, piece of mind, and having to look at it and deal with other people's debris and vermin. To us significance and the outsiders they sort of bypass it because they don't care about the way we look so why should we do anything for them. We've had that experience and I'm sure you have the Beautification committee was charged with title 13 and title 16. Title 13 primarily deals with the maintenance general type, and 16 is primarily dealing with littering and here's our philosophy and we've discussed this when we have our meetings mostly the proponent of this. I want everyone to know I'm a strong believer in private property rights and due process. We have a belief that the citizens need to be respected there needs to be equal treatment for all, we also have the belief that let me proceed before I say these human beings haven't been known to cooperate or that matter not fighting. Consequently, we came up with federal laws, state laws and now local laws. The local laws keep everybody straight with what they're doing there is no controversy essentially us that are on the beautification committee I say 95-97% people that live in Graysville believe that our ordinances are pretty practical and fair. The problem has been that the commission has failed to follow through on seeing those ordinances are met. I hate to say this but, in some substances, people have been treated differentially based on who they are. We feel if it was me, you or anybody else if there is an ordinance is unfair than there is a way of reappealing it, there's a proper legal way of reappealing it. In some cases, might be unconstitutional looking at them it's basic the ordinances that relate to those things you have charged us of doing. We want those ordinances enforced and I think were about that. At the same time, we want a neighborly approach to it we have been very well blessed with the citizens of participated with us and have been positive about this. We have appreciated the help from the city attorney, she's tried to keep us straight plus given us some good advice. Our judge has made it clear to those that come before him that were not interested in your money, were interested in you cleaning up. Only people that have been fined have not shown up or with multiple appearances before him have not done what he needed to do. Had not done what he needed to do. I guess I need to also say how much I appreciate the Fire department how much they do for Christmas for the kids as you said taking care of the kids. You know a commitment to be available at 3 in the morning. That would say it done for years or an emergency, the home visits, so on and so forth. And the appreciation of Mr. Miles and his wife that an those on the fire department. And our little police officer, Mr. Scott, Johnathon, I saw him talking to our kids, I will tell you about our volunteer group in a moment. We were out there working last Wednesday and I was wondering if he was getting on to them or something and I go over there and he's telling them how much he appreciates them and I greatly appreciate them and he's talking to citizens to try and coach them into doing things the right way so we don't have the to give them a citation. We don't want to do that, so I have to say I appreciate you and the judge, and I come to every court meeting to give Bill some support. Two things that was sort of brought to my attention as I have been chair of beautification committee, I was working on the Library the Veteran's wall that got damaged during Covid and I get a call from the office to come there standing Roy Peter who is representative of Laurel Brook school he wants to do volunteer work. As a student function to teach them community service this is a Monday or Tuesday and he wants to do it that Wednesday and I was scheduled and I couldn't do it that Wednesday so we made appointment that following Wednesday they were a little bit late, it wasn't an ideal weather

at the time and I thought this was going to fall through. If you have noticed that the main street of Graysville and I have contacted property owners with corporation 100% and we worked on the Sim's property, and Audrey's property now were at Ted May's and he says Ted and Vicki say do what you want to do and you want me to do what I want to do I went back a 2<sup>nd</sup> time yeah do what you want to do. That could be dangerous to tell me that this Wednesday tomorrow we will be working the 2<sup>nd</sup> time on Ted's property these kids come in like a whirl wind they work from the time there here till the time they leave. So far there using their own black garbage bags, buying their own gas, and different times brought their lawn mowers they have weed eaters, chain saws. They haven't asked me for one dime to reimburse for gasoline. If they come in the mornings, they miss lunch so I serve lunch, if they come in the afternoon, they will miss dinner these are dorm kids. We had kids from New York, California, Michigan, Kentucky, Georgia someone from Ecuador, Argentina tomorrow will be the last day to work till after the holiday. Then there coming back one of the representatives asked me if I would be available for them in the Spring for them God willing I will. The greatest need we need from the commission we need every one of you to support with the citizens on what where doing, because we're going to do it the right way. We're going to do it the neighborly way and if there is something you see and is wrong with our ordinances there is a process of changing that I don't think there are, but that's why your there. The 2<sup>nd</sup> thing I need critically is when we pick up debris, we put it on the side of the road it means it's going to sit there for a month Audrey's debris has sit for a while on the side of the road, or it's going to be picked up we know there is only certain pickup times, but this is pickup for beautification committee which you asked me to chair that committee and a volunteer group. It would be very helpful if your personal, because I know there stretched pretty thin, I have been over here a month or so watching everything going on if you bring your dump trailer and set it out and we take our debris and put it right on the dump trailer than you can take it to the dump. I would appreciate the support in doing that I hope I haven't left anyone out, because truly being on the planning commission even being in this role, I appreciate all the work I see being done. I can't thank the ones that have done it year after year after year because I'm kind of a long-distance runner myself. Do you have any questions of me?"

Mayor Kaylor, "You touched one variance if no one knows what she's talking about if someone comes before the planning commission wanting to put a house in a flood way years ago, they would give something called variance we can't do that in my book because if we start doing that, we want be able to get insurance. Who all here is with your committee, stand up just a minute? I know there's not a lot of people in here, but these people are dedicated to cleaning up our town. I would just like to thank you personally."

A motion made when there here cleaning up and take the trailer over there and leave it and get rid of the debris afterwards this city help them out 2<sup>nd</sup> by Commissioner Miles. Motion Passed 4-0.

### **Communities Unlimited GIS Mapping**

City Recorder Knox, "On this Communities Unlimited came to you in April or May when I started here and said, this is what they can do for your town and our services are free no charge. Since then that guy is no longer there, so now there is a different person now she is emailing me daily wants me to write her check for \$400.00 for GIS mapping. When I talked to the State, they told me the mapping is required but not required to be a paid service, it can actually be a hand drawn map. It's not due from us until 2023, so it's up to you if you want to pay \$400.00 for Communities Unlimited to do the GIS mapping through this third party to do it, and it is actually supposed to be a \$1100.00 fee normally they want us to pay \$400.00."

Mayor Kaylor, "Any nays, any yays I have no problem to amend it."

City Recorder Knox, "Got to have a 2<sup>nd</sup>."

Mayor Kaylor, "I'll 2<sup>nd</sup> it any discussion."

Commissioner Sulcer, "Barbara Claiborne you requested."

Barbara Claiborne, "I've gotten kind of a demonstration for you I appreciate you for a year when I walked the dogs here in this town, I pick up litter because I pick up poop. It was only after I got this dog bite, I realized I had to start carrying batons, taser, and I give up carrying the bear spray because I will kill my dog it is looking much better. Excuse me I'm Barbara Claiborne I've only been here 2 years I moved my mobile home here on Mike Knox property to spend the rest of my life. I want to pass around in case anybody missed the dog bite."

Chief Jonathon Scott, "Mrs. Barbara stand back here."

Commissioner Sulcer, "Jonathon will bring it to us if you want to show us."

Mrs. Claiborne, "This was in April black Australian Shepherd had me down on the ground he took me down with that bite down on my knee, he got me on my shoulder blade on 2 places, skinned my knee going down. I had my little dog underneath to protect her I took all the biting that led me to finding a lawyer trying to find out what laws cover this sort of thing all I could come up with one attorney said no because of the one bite law the first bite is allowed in Tennessee. I searched on the internet and sure enough there it was all over the place that dog got 5 bites I woke up the next morning I had more bites on me then I knew because my pjs were stuck to the sheets when I look at that I think of a 3-year-old face. The next morning the animal control officer came, and the dogs were gone I got concerned I was going to have to take rabies shot than the health department told me I couldn't even take the rabies shots because of my health issues. Then told me they could incubate in my body for a year there have been cases one survived 17-year-old girl I was going to start out talking about when I moved here 25 years ago to Rhea County. I've always rescued dogs Mopsi dog was attacked by 3 golden retrievers because I was babysitting a friend's 2-year-old we were out in the front yard the guy came in opened the door and here came the 3 and I grabbed the kid and ran they took my Mopsi and shook her like a rag doll. As the vet said tried to remove her left quarter panel basically, I went before Judge McKenzie, and I was awarded all the vet bills and so forth you can do that in Tennessee because my dog is property that has been damaged. A dog biting a human being isn't property that's the old English law. My son who is retired Chattanooga Police officer that sent me I could email them, but I couldn't email them to you'll and I couldn't email. This was the 2-10 law 2010 Tennessee title 44 Animal and animal husbandry fences and confinement running at large civil liability for injury caused by dogs. They have upgraded it now the owner doesn't have to know the dog has vicious necessities, but he can be sued. Thank God Tennessee is coming into civilization I'm going to be leaving this place. My son and daughter in law he's already retired his wife is retiring from Department of Defense up in Maryland D.C. there going to buy land and put me out on a 100 acres so she can run I walk my dog every day at least 2 miles I have done every route we got sort of a four leaf clover pattern we walk twice a day at least 2 miles a day it's good for me

it good for her as long as I have this. For one month I used it on the boxer who was the first one to bite not the second one he was the third. With every encounter were constantly attacked so many dogs are running lose the first one was the very first day I believe Scott the very first day I moved. I took Lucy for a walk this big black boxer threatening us, and I was backing up I was looking for a stump or something. I could swing the car stopped the van got out and said mam do you need help I said yes can I hide behind your truck he said I'm a police officer I said thank God. He hollered the woman's name and get out here and get your dog's I'm going to cite you."

Mayor Kaylor, "Was its Animal Control?"

Interim Chief Jonathon Scott, "It was Landon Trew."

Mrs. Claiborne, "It was Graysville Police Officer."

Mayor Kaylor, "In a truck."

Mrs. Claiborne, "He was off duty."

Mayor Kaylor, "Oh ok."

Mrs. Claiborne, "I should've made that clear he was helping a citizen that dog has been fenced since I walk by 3-4 times a week. I know it can be done the people could be cited for their dogs running lose you've got a law you're not enforcing it."

Mayor Kaylor, "Yes mam we have a leash law we prove the owner we have trained police officers that's all the city can do if we can find the owner."

Mrs. Claiborne, "That's what I'm good at because I'm out walking, I know were these dogs live."

Mayor Kaylor, "It's not just Graysville it's the State of Tennessee if I'm correct has a leash law it's not just here this problem is all over the county."

Mrs. Claiborne, "Well I was bitten then April a year ago woman just walked out open the door let the 5 dogs out went back in and I said oh and they were yapping and snapping whatever Lucy was between my legs and trying to get to her one came up and bite me there's a scar to. Animal Control was right out there that was when they were more accessible, he came and talked to the woman she cooperated she apologized the one who did this wasn't even an apology I got a lie oh my dogs weren't here. They were over yonder I know they were there because Carolyn Viera put me in her car we rode around, and they were there that night I only saw 3 she said she saw all of them all 4. I don't know whose friends and who's not who's going to get angry retaliate for the sake I'm going to come up with some suggestions. A workshop with consisting concerned citizens, councilmen, city attorney and Chief of Police that's one thing I don't want our policemen becoming dog catchers that's not their job. I started out by saying how many I would come across and would do it call them and here came Chief Roberson just as fast as he could get out of the car and go rambling with a dog in people's yards, I quit doing that. I just wanted people to see the real problem if you don't get out and walk you don't see it, I want someone to walk with me if I could and authorize and sworn in, I could serve a summons."

Mayor Kaylor, "We have a police officer to serve summons."

Mrs. Claiborne, "I'm just saying but not just as a policeman but a patrol dog patrol. Get a workshop considered dog patrol officer to issue citations and serve summons to court fines pay his salary if you charged enough if you doubled it with the 2<sup>nd</sup> one, I guarantee you wouldn't have many and need the patrol."

Mayor Kaylor, "I don't mean to interrupt but as far as charging double you can't do that you have a certain amount of money by law you cannot fine them more than that."

Mrs. Claiborne, "I see were if it were done."

Officer Scott Freeman, "That statute you read off 4408 there is a sequence of events that actually have to happen so if that one dog bites multiple times multiple offenses have to climb so if there's the scale it has to start at the very bottom first when that first bite."

Mrs. Claiborne, "I do know the dog some of them it's there first time out they just gotten lose, there are others that are continuously offenders let's put it that way. I think there needs to be more emphasis when your register for your water people, have told me that it's a laugh that the city only had you sign up register your dog to make a little money and they don't do it. There are dogs without collars, dogs without tags there's dog if they have rabies, they don't have a city tag. Who's going to enforce that?"

Mayor Kaylor, "Once again we have to prove who's dog it is we can do that then we can charge them for not registering and dogs running at large TCA codes."

Mrs. Claiborne, "These things are something a committee could come up with or get some legal help."

Mayor Kaylor, "I will try and contact Animal Control if they would be available for a workshop."

Mrs. Claiborne, "The county."

Mayor Kaylor, "Yes mam that's the only Animal Control we have I think there's 3 of them that does the whole county."

Mrs. Claiborne, "I can walk in Dayton in peace and the alleys aren't even littered."

Mayor Kaylor, "I agree, like I said if we can't prove who's it is our hands are tied."

Mrs. Claiborne, "I mean how many people have come moved in registered for their water and didn't have a dog when they moved in, but they acquired 4 since then."

Mayor Kaylor, "I can't answer that I have no idea on dogs and who has what."

Mrs. Claiborne, "There we go."

Mayor Kaylor, "There's no way telling that."

Mrs. Claiborne, "I would say cut their water."

Mayor Kaylor, "Can't do that. We must abide by the Law also. You can't cut someone's water off because they have a dog."

Mrs. Claiborne, "Unregistered."

Commissioner Miles, "I did see Richard down here 3x's."

Mrs. Claiborne, "Maybe what I'm doing is working bopped dogs over the nose the one before that I got across the back."

Mrs. Carol Smith, "Well what I would like to say as some of you know we had a little mishap over the weekend you may have even seen it on Channel 9 news. I would just like to express mine and my husband's gratitude towards the mayor and his wife the Vice Mayor and his wife for being concerned and checking on us you even came down. Chief Jonathon was there like within seconds seemed like and I couldn't get the husband out of the house but as soon as he came and told him he had to leave he got out. I feel like he may have saved my husband I would just like to thank him the fire department for

coming and taking they was just right on it they went in did what they needed to do they stayed more than they really had to. They came back and checked on us I just can't thank the fire department enough. I just wanted everybody to know what a great job they did."

Mayor Kaylor, "I was there they did a quick job by the way did your husband ever get his biscuits."

Mrs. Smith, "He still ain't got his biscuits I think I'm going to throw the biscuits away. Bo Kaylor was great he got my fire report to me I just can't thank everybody enough that was concerned and saved our house. Now our house looks like a total disaster the stuff that is damaged can be replaced I'm not so much worried about the stuff that's lost its when you see how devastating the stuff looks is just overwhelming. Anyway, I just wanted to thank everyone that came Saturday and helped us, I just can't thank you enough."

Mayor Kaylor, "Your more than welcome I didn't do anything but give you moral support. The fire and police department were johnny on the spot."

Mrs. Smith, "Yes they were I looked up and Chief Jonathon was there within seconds you know just you'll checking on us was really appreciated. Sometimes it's just the little stuff that means the most."

Gail Harrold, "I feel like Barbara is saying that towards us because you know she kept walking that dog and I think I'm not for sure yeah we have homeowners, and I've asked David are you the one that told he r were we had it. He said he didn't I don't know but it doesn't matter she tried to sue us over this the dogs and our dogs Jeff's dogs was in the pen. Everybody knows she's passed that around she's even been seen putting her little dog in the yard where a dog was tied up and what do you call that I don't know them big words. You don't do that to a dog that is in their own yard she's mostly throwing that at us, and she tried to sue us, and she didn't have no case. She may go back and sue us and get a lot I don't know or get what we got I don't care. She could've just come talk to me we got it settled but she didn't she couldn't prove it was Jeff's dog. She doesn't come down our street anymore she goes down this way and Carol Carolyn would get out there and say that crazy woman. I told Carolyn don't do that stay in the house don't do that because it upset her little dog. Dogs are going to bark at other dogs, but this biting deal I wasn't there whenever it happened, I've heard it and heard till I'm sick of hearing it. We can fight it talk it out coarse it out I don't care. Everybody knows who she's talking about mainly us. Jimbo, you know about it most of you'll do. So, she's put that on us there's dogs down the road."

Mrs. Claiborne, "Long before this."

Mrs. Harrold, "You had your time I'm talking."

Mayor Kaylor, "Point of order."

Mrs. Harrold, "That's all I have to say if she has anything to say we will talk it out."

Citizen in the Crowd, "Excuse me can I say something about the dog issue?"

Mayor Kaylor, "Who said that if you make it quick because you didn't sign up, I'll allow it."

Mrs. Anna Scott, "Me and my mom can't go the dogs is a problem 2 years ago I could walk from one end to Graysville to the other and back home and not have a problem. I have lived here my entire life and never been afraid to walk around Graysville until now we can't go to either end of our street without a dog coming after us the one coming from Harrison, corner of Harrison and Shelton both sides then go

the other way, and you get chased by dogs. These aren't dogs that are cooped up these are dogs that are let out to run loose."

Mayor Kaylor, "Do you know who's they are?"

Mrs. Scott, "I don't know anybody I've lived here but I don't know people's names."

Mayor Kaylor, "If you find out who they belong to contact the police department."

Mrs. Scott, "I get tired of calling the police because it doesn't do any good, we've been harassed there is a dog problem she's not exaggerating."

Mayor Kaylor, "I know there's a dog problem."

Mrs. Scott, "So I just feel like it's sad we can't go walking we need to walk you know she's unhealthy and needs to go walking."

Citizen in the Crowd, "I can't go walking past the corner because of the dogs."

Mrs. Scott, "Were not even walking dogs."

Mayor Kaylor, "it's not just here there's a dog problem everywhere as I mentioned before unless we can prove who's dog it is or if they can catch it that's the only thing we can do."

Mrs. Scott, "Thank you for allowing me to speak."

#### **Communications from Mayor and Board of Commissioners**

Vice Mayor Crawley, "I suggest carry a notepad with you note the address."

Mrs. Scott, "What are we supposed to do if we get attacked? How does this poor ole lady laying on the ground twice her size I don't understand the concept? You don't get to get anything done until you're attacked."

Vice Mayor Crawley, "No that's not what I'm saying you said you was walking. Dogs running loose."

Mrs. Scott, "No."

Mayor Kaylor, "Point of order were not going to sit here and argue we know there's a dog problem. You signed up for citizen input you've had your time it's time for the commission to talk. Another outburst I have the police officer escort you out whoever it is."

Vice Mayor Crawley, "I realize we have a dog problem write down the addresses down the houses turn it over to Jonathon or whoever is on duty, let them check into it if the dogs are loose need to make a report. Possibly get them picked up or taken care of."

Commissioner Miles, "Does the animal shelter have a contact number?"

Mayor Kaylor, "Yeah this is number 8 anything else?"

Vice Mayor Crawley, "I'm done."

Commissioner Sulcer, "I like to thank everyone for coming out, and I know I like to take it one step farther everybody has cell phones take a picture of the dog because a lot of times a animal control comes down here the dog is gone. No matter if we call them or not, he can get down here there's 3 of them for this whole county that's it by the time he gets down here an hour or 2 hours that dog is going to be gone. Take a picture of the dog best you can show that picture to animal control or the officer and maybe they can do something with it. By the time they get down here there not close there on a call, or

I think right now Richard's trucks in the shop you never know. Try take a picture if you can dog running loose."

Mayor Kaylor, "Anything before closing?"

Commissioner Miles, "I just want to say you know people want to walk in town we have a nice park it got a walking track I'm not saying if you haven't been up there, they done a nice job on it. It's a nice place to walk. Mike how much money did you'll raise on the roadblock."

Fire Chief Mike Miles, "My chairperson will tell you."

Mrs. Susan Miles, "So far the total I have come up with \$5400.00 give her take got another donation today that adds another \$200.00 we got \$300.00 coming from Lazy boy next week roughly around \$5500.00. Thanks, from the town of Graysville."

Commissioner Miles, "A lot of that is from the roadblock."

Mrs. Miles, "\$3,246.00 from the first roadblock, 2<sup>nd</sup> one was \$889.00 we were only our roughly a hour and forty five minutes that was a blessing the rest has come from donations coming in. \$700.00 was from the jeep ride Tennessee Jeepsters."

Mayor Kaylor, "It's the true work like that the children of Graysville this community will have Christmas."

Commissioner Miles, "Citizens donated that much."

Mrs. Miles, "We have approximately 35 kids the applications that was turned in."

Mayor Kaylor, "That aorta give them a good Christmas. Like I said I will try and plan with animal control probably have a meeting other than that. Crystal, don't we need to have amend the agenda on the library soon."

City Recorder Knox, "Yes."

Mayor Kaylor, "Go ahead and explain if you haven't told all of them."

City Recorder Knox, "I don't have the paperwork with me but whenever you'll did the budget, you'll shorted the library by \$800.00 from what was spent from the prior year. We will be doing a budget amendment soon to be able to."

Mayor Kaylor, "We need to ASAP that because until we amend our budget none of the county is getting that money."

City Recorder Knox, "We will also be doing a budget amendment for Trevor's truck for the water department \$3500.00, is how much it took to fix it and we only appropriated \$1000.00 for repairs for vehicle."

Mayor Kaylor, "Get the paperwork ready and we will call a meeting."
